I am registering my child for the Preschool Summer Vacation Club Program:

Tuition is based on the number of weeks your child is enrolled to attend the Summer Vacation Club Program. We will participate in swim, 3 times per week as well as outdoor/indoor gross motor activities. Please provide your child with sunblock, flip flops, towels, and bathing suits each day.

In addition as the parent, I understand and agree to:

- **Pay a \$50.00 non-refundable, non-transferable deposit per week due at registration.** I understand that if I cancel or withdraw from the program the deposit is non-refundable and non-transferable.
- Pay a late pick up fee of \$1.00 per child each minute after the program ends at 6pm.
- **All balances are due by July 1st.** If you are signing up after July 1st, tuition is due no later than the Wednesday before the child's start date.
- A completed registration packet is due at the time of registration.
- Update registration information as needed. (Example: New phone number, change of address, allergies, etc.)
- Pay a \$25.00 charge for any check that is returned from the bank. (Check must be replaced with a certified check or money order.)
- Provide the program with all completed registration forms, physical within the year, immunization records, and any IEP's, with the registration form. **Any child with any allergies or medications MUST come with the medication along with a completed Medical Consent Form (found in the packet) before the child starts. If we do not receive the medication the day of your child's start date, the program will not be able to take your child.**
- Abide by the guidelines stated in the parent handbook.
- Provide **a four-week written notice** to change my child's scheduled session or to cancel my child out of the program. My child may switch sessions if there is space available on the requested week. I understand I am responsible for payment during this period.

- Provide trained, qualified staff
- Provide supervised social, educational, and recreational activities
- Provide advanced notice of field trips and vacation week programs
